Advertisers who do not supply artwork by December 6, 2018 forfeit their space and will not receive a refund. Changes to ads made after December 6, 2018, will be subject to a \$300 change fee. Changes to ads will not be accepted after December 12, 2018. This includes cancellations, adding or canceling color, and ad size changes.

In addition, ad cancellations on/or after December 6, 2018 will not receive a refund.

ARTWORK REQUIREMENTS

Setting up your artwork:

- Publication trim size: 8.5" x 10.875"
- BLEED AD: 8.75" x 11.125"
- NO BLEED AD: 8" x 10.375"

Submitting your artwork:

- PDF ad submission is required. Create your PDF using Standard: X-1a.
- Filename should include your company name.
- Submit artwork under 5MB to: ala@heexpo.com or for larger files please request FTP information.

Also, note:

- Recommended that ads include .25" margin from trim.
- For color ads, design in CMYK, spot colors will be converted.
- For grayscale ads, only use black ink, built black (using CMYK) will be converted.
- Color reproduction is assured to generally-accepted industry standards.
- Do not include any printers marks, crop marks, etc. in your PDF.
- If you need assistance setting up your artwork or submitting file-types other than PDFs please contact ala@heexpo.com.
